L'Arche Tahoma Hope has four group homes and in 2009 we supported 14 individuals with developmental disabilities. Each home provides assistance to each individual to maintain his/her health & safety, to enhance his/her self-esteem & to support each in maintaining optimum power and choice in his/her life. This assistance includes enhancing life skills, providing personal care & accompanying individuals in opportunities and engagement with the larger community.

L'Arche Farm & Gardens, a group supported employment site that provides employment and volunteer opportunities for individuals with developmental disabilities, supported 8 individuals in 2009. L'Arche Noah's Workshop, a prevocational day program, supported 8 individuals in 2009. Both of these programs within L'Arche focus on the gifts and skills of individuals with developmental disabilities and provide meaningful work and/or volunteer opportunities.

General L'Arche community expenses benefit the growth and support of the community as a whole and provide recognition of the value and wholeness of persons with developmental disabilities.
