This assistance includes enhancing life skills, providing personal care & accompanying individuals in opportunities and engagement with the larger community.

4b (Code: ) (Expenses \$ 288,302 including grants of \$ 0 ) (Revenue \$ 0 ) L'Arche Farm & Gardens, a group supported employment site that provides employment and volunteer opportunities for individuals with development al disabilities, supported 9 individuals in 2010. L'Arche Noah's Workshop, a prevocational day program, supported 8 individuals in 2010. Both of these programs within L'Arche focus on the gifts and skills of individuals with developmental disabilities and provide meaningful work and/or volunteer opportunities.
